- You work well with others and are accountable for your words and actions
- You care about and can be generous to the community

General duties of a Director are as follows

- Prepares for Board meetings in advance and arrive promptly at meetings and stay until the meeting is adjourned
- Attends all monthly Board meetings (except July and August)
- Be an ambassador for and always ready to build the profile and reputation of Little Lantern in the community
- Supports the fund and resource development endeavours of Little Lantern
- Manages and supervises the activities and internal affairs of Little Lantern
- Always acts honestly and in good faith with a view to the best interests of Little Lantern
- Exercises the care, diligence and skill that a reasonably prudent individual would exercise in comparable circumstances
- Have a thorough knowledge of the Little Lantern's constitution and by-laws
- Works with other Directors to ensure that Board policies and practices are current and that they are adhered to
- Ensures that the financial structure of Little Lantern is adequate for its current and future needs
- Ensures that Little Lantern is in compliance at all times with legal requirements

Other Duties
